



### **GoMoWorld St Patrick's Day Data Plan Giveaway Competition**

1. The GoMoWorld data plan giveaway competition (the "Competition") is open to all GoMoWorld followers who have downloaded the GoMoWorld app on a compatible mobile device. Entrants must be aged 18 years and over.
2. By entering this Competition, participants agree to these Competition terms and conditions.
3. Employees of GoMoWorld and its affiliates and associated promotional partners, companies or suppliers and their immediate family members are not eligible to enter/win the Competition.
4. The Competition will be moderated and only legitimate entries will be accepted for entry, no inappropriate entries will be counted.
5. Only one entry is allowed per participant per platform.
6. The Competition must be entered via GoMoWorld's social channels (Facebook, Instagram, Twitter or TikTok). [Username: @GoMoWorld\_ with entries limited to one per user per platform.] Entrants must answer the specific question asked (different questions on each social media channel, tailored to content style). Entrants will also need to like GoMoWorld's post, follow the GoMoWorld account and tag another account (where specified) to be in with a chance to win a free plan.
7. The prize will be four free GoMoWorld 30 day data plans for an available location of our four prize winners choosing (one data plan for one winner per platform). There will be one data plan per winner, and the winners will need to have an eSIM compatible device and download and sign in to the GoMoWorld app to redeem their prize. The winners will need to supply GoMoWorld with their sign in details (email or phone number used to sign into the app) so we can identify them to provision their plan and contact them to confirm their plan is in place.
8. The Competition will start at 6:00 pm on 16<sup>th</sup> March 2023 and the Competition will close at Midnight Sunday 19<sup>th</sup> March 2023.
9. The prize winners of the Competition will be selected from all valid entries received by GoMoWorld on Monday 20<sup>th</sup> March 2023.
10. GoMoWorld will notify the four Competition prize winners by the original social media post, asking the four winners to contact the GoMoWorld account via DM to proceed with prize giving.

11. GoMoWorld will notify the four prize winners by means of a comment reply on Facebook, Instagram, Twitter & TikTok. If any of the prize winners fail to respond after being contacted their prize will be forfeited.
